THE MANUAL CHAPTER 0350 PROCESS AT DAVIS-BESSE

On September 10, 2003, the Nuclear Regulatory Commission (NRC) held two public meetings at the Oak Harbor High School in Oak Harbor, Ohio. The first meeting was between the NRC Davis-Besse Oversight Panel and FirstEnergy Nuclear Operating Company (FENOC) to discuss recent inspection results and the licensee's Return to Service Plan for Davis-Besse Nuclear Power Station.
