





NRC Resource Implications

- NRR FY2004/2005 new reactor resources reduced to support additional license renewal reviews
- Available NRR resources being used for
 - Early site permits
 - AP1000 design certification
 - ESBWR and ACR-700 preapplication reviews
 - Construction Inspection Program
 - COL issues
- Increased interactions on COL issues will be limited by resources
- Planning for one COL application in FY2006
- Additional early site permit or COL applications will be a challenge


