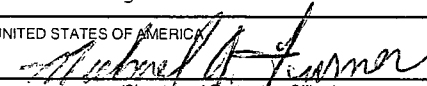

The purpose of this modification is to provide incremental funding in the amount of \$50,000.00, thereby increasing the obligated amount of the contract from \$1,751,000.00 to \$1,801,000.

Accordingly, the contract is hereby modified as follows:

Under Subsection B.2 - CONSIDERATION AND OBLIGATION - DELIVERY ORDERS, Paragraph (b) is deleted in its entirety and substituted with the following in lieu thereof:

"(b) The amount presently obligated with respect to this contract is \$1,801,000.00. The Contracting Officer may issue orders for work up to the amount presently obligated. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph a above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk."

A summary of obligations for this contract from award date through the date of this action is given below:
