Subject: Transmittal of the US-APWR Test Plan Summaries.

With this letter, Mitsubishi Heavy Industries, LTD. (MHI) transmits to the U.S. Nuclear Regulatory Commission (NRC) the documents entitled "US-APWR Reactor Vessel Lower Plenum 1/7 Scale Model Flow Test Plan" and "US-APWR Neutron Reflector Reflooding Test Plan" in response to the NRC's request. For the NRC staff's information, MHI had previously transmitted the US-APWR test schedule by MNES's letter dated February 16, 2007 (MNES Ref: NS-USAPWR-07-01) and by MHI's documents dated April 19, 2007 (MHI Ref. UAP-HF-07040 and UAP-HF-07041). In the enclosed documents, MHI provides the latest, more detailed information concerning the tests planned for the US-APWR. This information includes the detailed schedule for performing the tests which should enable the NRC technical and quality assurance staff to schedule their visits to Japan for witnessing the tests.

As indicated in the enclosed materials, these documents contain information that MHI considers proprietary, and therefore should be withheld from disclosure pursuant to 10 C.F.R. § 2.390 (a)(4) and 10 C.F.R § 9.17 (a)(4) as trade secrets and commercial or financial information which is privileged or confidential. Non-proprietary versions of the documents are also being submitted in this package (Enclosure 3 and 5). In the non-proprietary versions, the proprietary information, bracketed in the proprietary version, is replaced by the designation "[]".

This letter includes copies of the proprietary versions (Enclosure 2 and 4), copies of the non-proprietary version (Enclosure 3 and 5) and the Affidavit of Masahiko Kaneda (Enclosure 1) which identifies the reasons MHI respectfully requests that all materials designated as "Proprietary" in Enclosure 2 and 4 be withheld from disclosure pursuant to 10 C.F.R. § 2.390 (a)(4) and 10 C.F.R. § 9.17(a)(4).

AFFIDAVIT

I, Masahiko Kaneda, state as follows:

1. I am General Manager, APWR Promoting Department, of Mitsubishi Heavy Industries, LTD ("MHI"), and have been delegated the function of reviewing MHI's US-APWR documentation to determine whether it contains information that should be withheld from disclosure pursuant to 10 C.F.R. § 2.390 (a)(4) and 10 C.F.R. § 9.17(a)(4) as trade secrets and commercial or financial information which is privileged or confidential.
2. In accordance with my responsibilities, I have reviewed the enclosed documents dated July 13, 2007, entitled "US-APWR Reactor Vessel Lower Plenum 1/7 Scale Model Flow Test Plan" and "US-APWR Neutron Reflector Reflooding Test Plan" and have determined that portions of the documents contain proprietary information that should be withheld from public disclosure. Those pages containing proprietary information are identified with the label "Proprietary" on the top of the page and proprietary information has been bracketed with an open and closed bracket as shown here "[]". The first pages of the documents indicate that all information identified as "Proprietary" should be withheld from public disclosure pursuant to 10 C.F.R. § 2.390 (a)(4).
3. The information identified as proprietary in the enclosed documents has in the past been, and will continue to be, held in confidence by MHI and its disclosure outside the company is limited to regulatory bodies, customers and potential customers, and their agents, suppliers, and licensees, and others with a legitimate need for the information, and is always subject to suitable measures to protect it from unauthorized use or disclosure.
4. The basis for holding the referenced information confidential is that it describes the unique information concerning each of the tests, developed by MHI and not used in the exact form by any of MHI's competitors. This information was developed at significant cost to MHI, since it required the performance of Research and Development, detailed design for its software and hardware extending over several years.
5. The referenced information is being furnished to the Nuclear Regulatory Commission ("NRC") in confidence and solely for the purpose of information to the NRC staff.
6. The referenced information is not available in public sources and could not be gathered readily from other publicly available information. Other than through the provisions in paragraph 3 above, MHI knows of no way the information could be lawfully acquired by organizations or individuals outside of MHI.
7. Public disclosure of the referenced information would assist competitors of MHI in their design of new nuclear power plants without incurring the costs or risks associated with the design of the subject systems. Therefore, disclosure of the information contained in the referenced documents would have the following negative impacts on the competitive position of MHI in the U.S. nuclear plant market:

- A. Loss of competitive advantage due to the costs associated with development of the test method for confirming the enhanced design of the US-APWR. Providing public access to such information permits competitors to duplicate or mimic the test method for their plant designs without incurring the associated costs.
- B. Loss of competitive advantage of the US-APWR created by benefits of enhanced plant safety, and reduced operation and maintenance costs associated with the enhanced US-APWR design to be confirmed by the associated tests.

I declare under penalty of perjury that the foregoing affidavit and the matters stated therein are true and correct to the best of my knowledge, information and belief.
