Assessment Program

- **Assessment Program Objectives**
 - Collect information from construction inspections
 - Objectively determine licensee performance
 - Guide timely and predictable decisions regarding Agency actions
 - Provide a process for informing stakeholders of the NRC's assessment
 - Provide a process to follow-up and close-out areas of concern
- **Elements of Assessment Program**
 - Inspection insights
 - Process for evaluation of individual issues
 - Process for periodic assessment of licensee performance
 - Response levels for increasing regulatory oversight
 - Stakeholder involvement and meetings



Assessment Program

- Overall licensee performance will be determined by Severity Level (SL) I, II and III violations and substantive cross-cutting issues.
- NRC response will use a graded approach and may result in increased ITAAC inspection(s) in the area(s) of concern, Confirmatory Action Letters, Demands For Information (DFIs), and/or Orders.
- Staff is evaluating appropriate cross-cutting areas to be considered.

Assessment Program Nominal Program Review Column

- **Criteria**
 - No greater than SLIV violations
 - No substantive cross-cutting issues
- **Licensee corrective action**
- **Nominal inspection program**
- **No additional regulatory actions**



Assessment Program

Limited Expanded Program Review Column

- **Criteria**
 - No greater than one SLIII violation or one substantive cross-cutting issue.
- Licensee root cause evaluation and corrective action with NRC oversight.
- Limited increase in NRC oversight in area(s) of concern.
- No additional regulatory actions if corrective actions (CAs) are acceptable.



Assessment Program

Expanded Program Review Column

- Criteria
 - No greater than a total of three SL III violations or substantive cross-cutting issues or one SL II violation
- Licensee cumulative root cause evaluation with NRC oversight
- Expanded NRC oversight in area(s) of concern. ITAAC sample increased as appropriate.
- No additional regulatory actions if CAs are acceptable. NRC will evaluate continued use of Non-Cited Violations.



Assessment Program Unacceptable Performance Column

- Criteria
 - One SL I violation, multiple SLII violations, or a combination of the following: 1 SL II and a total of four SL III violations/ substantive cross-cutting issues; or a total of seven SL III violations and substantive cross-cutting issues.
- Loss of confidence to construct within licensing requirements in area(s) of concern.
- Licensee performance improvement plan and independent inspection with NRC oversight
- Reactive team inspection in area (s) of concern.
- DFI's, "show cause," and/or Orders.
- Commission meeting with senior licensee management.
