SUBJECT: SUMMARY OF THE AUGUST 27, 2009, PUBLIC MEETING WITH LUMINANT GENERATION COMPANY, LLC TO DISCUSS THE UPCOMING COMANCHE PEAK NUCLEAR POWER PLANT REFERENCE COMBINED LICENSE APPLICATION, REVISION 1

On August 27, 2009, a Category 1 public meeting was held between the U.S. Nuclear Regulatory Commission (NRC) and Luminant Generation Company LLC (Luminant) at the U.S. Nuclear Regulatory Commission's Twinbrook Building located at 12300 Twinbrook Parkway, Rockville, Maryland. The purpose of this meeting was to briefly discuss the upcoming Revision for the Comanche Peak Nuclear Power Plant Combined License Application (COLA). Enclosure 1 lists the meeting attendees. Enclosure 2 is the Meeting Handout that Luminant provided to the NRC staff, entitled Plan for Comanche Peak 3 & 4 COLA Revision 1, and can be found in the Agencywide Documents Access and Management System (ADAMS) under Accession Number ML092530704.

Luminant opened this meeting by discussing the differences between Revision 0 and Revision 1 of the COLA. Revision 1 of the COLA will include changes to the application that have been previously submitted to the NRC staff as either Updated Tracking Reports (UTRs) or responses to the NRC staff's Requests for Additional Information (RAIs). Over the past several months, Luminant had submitted several UTRs to the NRC staff. These UTRs contain revisions to the COLA Final Safety Analysis Report (FSAR), based on the NRC's site audits, United States - Advanced Pressurized Water Reactor Design Certification Document changes, or NRC staff's RAIs. Luminant stated, that because Revision 1 of the COLA would only include FSAR changes already included on UTRs and responses to RAIs, the NRC staff should not see any unanticipated changes to the COLA. The NRC staff anticipates receiving Revision 1 of the COLA on November 20, 2009.

This was a Category 1 public meeting. The public was invited to participate in this meeting by providing comments and asking questions throughout the meeting. However, there were no members of the public present at this meeting.
