BACKGROUND:

Strata submitted a Letter of Intent to the U.S. Nuclear Regulatory Commission. (NRC) staff on October 5, 2009. This letter notified the staff that it intends to submit an application to operate an ISR at the Ross site in Crook County, Wyoming. Strata will submit this application in December 2010.

DISCUSSION:

NRC staff read the opening statement for the meeting and Strata proceeded to present its slide presentation of the project. Slides presented at this meeting are included as Attachment 3. Strata's presentation focused on the geologic modeling investigations and resulting model for the site, as well as plans for the hydrogeologic investigation. After the slide presentation, NRC staff reviewed the licensing process with Strata and emphasized the need to discuss particular subjects during future meetings.
