

## MEETING REPORT

PURPOSE: This meeting was held at the request of NCA Nuclear, Inc. (NCA) to introduce the company to U.S. Nuclear Regulatory Commission staff and to discuss the proposed Reno Creek *in situ* recovery (ISR) project in the State of Wyoming (see Attachment 1).

### BACKGROUND:

NCA submitted a Letter of Intent to the U.S. Nuclear Regulatory Commission staff on May 26, 2010, which supplemented its original letter of April 9, 2010. This letter notified the NRC staff that it intends to submit an application to operate an ISR at the Reno Creek site in Campbell County, Wyoming, by the end of 2011. The letter also informed the staff that the licensee and operator would be AUC LLC (AUC).

### DISCUSSION:

NRC staff read the opening statement for the meeting and NCA proceeded to present its slide presentation of the project. Slides presented at this meeting are included as Attachment 3. NCA's presentation focused on the following topics:

- Introduction to AUC LLC
- Project overview
- General environmental baseline plans and schedule
- Conceptual geologic model
- Conceptual hydrologic model and pumping test
- Underground injection permitting status
- Proposed water quality sampling alternative
