SUBJECT: SUMMARY OF JULY 29, 2010, NRC CONSTRUCTION  
INSPECTION PROGRAM CATEGORY 2 PUBLIC MEETING  
WITH INDUSTRY AND THE PUBLIC TO KICKOFF THE  
SIMULATED INSPECTIONS, TESTS, ANALYSES, AND  
ACCEPTANCE CRITERIA (IT AAC) CLOSURE AND  
VERIFICATION DEMONSTRATION AND TO DISCUSS NRC  
REGULATORY ISSUE SUMMARY (RIS) 2008-05, REVISION 1  
“LESSONS LEARNED TO IMPROVE INSPECTIONS, TESTS,  
ANALYSES, AND ACCEPTANCE CRITERIA SUBMITTAL.”

On July 29, 2010, the NRC, Office of New Reactors (NRO) held a public meeting to discuss topics relating to new reactor construction (Agencywide Document Access and Management System (ADAMS) Accession Number ML101960558). The purpose of the meeting was to kickoff the simulated IT AAC closure and verification demonstration project and to discuss RIS 2008-05, Revision 1.

The meeting opened with remarks by Richard Laura of the Construction Technical Specifications and IT AAC Branch (CTSB) in the Division of Construction Inspection and Operational Programs (DCIP). Mr. Laura provided an overview on the proposed IT AAC closure and verification demonstration; highlighting the roles of participants and the need to keep the NRC Project Engineer, Mahmoud Jardaneh, informed of any potential issues, problems, or deviation in scope or direction from the established plan (ML101960548).

These highlights included an overview of the demonstration scope, the ITAAC selected for the demonstration, and the project plan. Mr. Jardaneh indicated that by conducting the simulated demonstration, participants would gain insights on the readiness of both the industry ITAAC closure process and the NRC closure verification process. Mr. Jardaneh also indicated that the simulated demonstration will test aspects of the construction assessment and enforcement programs; as well as evaluate the surge in ITAAC closure submittals expected during the last year of construction. The demonstration is expected to conclude by the end of March 2011.

The presentation was followed by a discussion on the logistics and various aspects of the demonstration. Participants in the meeting discussed the availability of proprietary information for NRC staff review, the submittal of ITAAC closure letters, and the establishment of a project number for the demonstration. Additionally, participants in the meeting agreed to add a sixth ITAAC, Design-Reliability Assurance Program (D-RAP), to the five ITAAC previously selected for the demonstration.

Next, Jose Jimenez of DCIP presented on the "Role of Enforcement, Assessments, and Allegations on ITAAC Closure and Verification." Mr. Jimenez presentation (ML102110003) included scenarios that could be used during the demonstration. These scenarios would be used to exercise aspects of the enforcement, assessment, and allegations programs.

Finally, Calvin Cheung of DCIP presented highlights of the updates included in RIS 2008-05, Revision 1 (ML101450192), "Lessons Learned to Improve Inspections, Tests, Analyses, and Acceptance Criteria," (ML102110006). The RIS communicates good practices associated with the quality, clarity, and inspectability of ITAAC submitted as part of applications for early site permits, standard design certifications (DCs), or combined license applications (COLs). The revision expands on issues that were identified in the original RIS 2008-05 and incorporates several new issues. Participants in the meeting discussed some of these updates, particularly the recommendation that vendor and licensees provide complete ITAAC lists with each DC and COL revision. The RIS had been recently published for public comment on July 20, 2010.
