**Proposed Schedule for Transmittal of Requested Information Supporting the  
Environmental Review**

Reference: Letter from Dr. Donald E. Palmrose (NRC) to John Elnitsky (PEC), dated January 13, 2011, "Request for Additional Information for the Environmental Review of the Combined License Application for the Shearon Harris Nuclear Power Plant, Units 2 and 3"

Ladies and Gentlemen:

In the reference letter, the Nuclear Regulatory Commission (NRC) transmitted to Progress Energy Carolinas, Inc. (PEC) requests for additional information (RAI) needed to support the environmental review of the Shearon Harris Nuclear Power Plant Units 2 and 3 (HAR) combined license application. NRC also requested that PEC provide a proposed schedule for transmittal of responses to the RAIs detailed in the letter. PEC hereby provides the following proposed schedule:

For the Need for Power RAIs (1.1.7-1, 8.0-1, 8.3-1, 8.3-2, and 8.3-3), responses will be provided by March 31, 2011.

For the Alternative Systems Needs RAI (9.4-3) and the GIS Data Needs RAI (3.1-1), responses will be provided by September 30, 2011. The schedule for these responses is based on PEC's 401/404 permit application process, since these responses will be more completely informed by efforts on-going this year to support the permit application process. The response for the Alternative Systems Needs RAI (9.4-3) could be provided by June 30, 2011, if the RAI did not require information based on in-stream flow studies (IFIM) and normalized Cape Fear River water quality data which are permitting activities associated with the 401 Water Quality Certification that PEC is pursuing in addition to the COL.
