SUBJECT: SUMMARY OF JANUARY 26, 2012, CATEGORY 3 PUBLIC
MEETING TO DISCUSS REGULATORY BASIS AND GUIDANCE
DEVELOPMENT TO CLARIFY 10 CFR PART 21 "REPORTING
OF DEFECTS AND NONCOMPLIANCE"

On January 26, 2012, the U.S. Nuclear Regulatory Commission (NRC) staff hosted a Category 3 public meeting in the Two White Flint North Auditorium, 11545 Rockville Pike, in Rockville, Maryland. The purpose of the meeting was to discuss the NRC's rulemaking process, schedule, and allow industry and interested stakeholders the opportunity to participate in the regulatory basis and guidance development to clarify the requirements of Title 10 of the Code of Federal Regulation Part 21 "Reporting of Defects and Noncompliance" (Part 21). The meeting notice is documented in the Agencywide Documents Access and Management System (ADAMS) under accession number ML12006A194. All presentations given during the meeting are documented in ADAMS under accession number ML12024A267.

Richard Rasmussen, Branch Chief of the Electrical Vendor Branch (CEVB) in the Office of New Reactors (NRO) Division of Construction Inspection Programs (DCIP) opened the meeting and welcomed the participants. George Tartal, Senior Project Manager in the Division of Advanced Reactors and Rulemaking (DARR) gave a brief overview on NRC rulemaking. Stacy Smith of CEVB followed with a presentation on the status of the Part 21 rulemaking and regulatory guide development.
