As previously indicated in public announcements and meetings, the Detroit Edison Company is developing a Combined License Application (COLA) for submittal to the U.S. Nuclear Regulatory Commission (NRC) in accordance with the requirements of 10 CFR 52 for a potential new Fermi 3 nuclear power plant. The COLA outlines Detroit Edison's plans for construction and operation of a proposed new power plant at the existing Fermi site near Newport, Michigan.

A key part of the COLA is the development of emergency plans which provide information sufficient to demonstrate compliance with pertinent regulatory requirements. The COLA will take credit for the federal, state, and local plans already in place that support Fermi 2, and will include an emergency plan which addresses onsite and offsite activities to support an additional plant. The support that would be required of the Michigan State Police associated with an additional new power plant is expected to be the same as is now required to support the existing Fermi 2 plant.

The COLA Emergency Plan includes a description of the emergency classification system for the new plant, as required by NRC regulations. Detroit Edison has worked with the nuclear industry to develop a set of initiating conditions and emergency action levels consistent with the emergency classification system and appropriate to the proposed new nuclear plant design. In addition, the Fermi site evacuation time estimate for has been updated with input from various state and local government agencies. The evacuation time estimate report is also included in the COLA.

Emergency planning provisions of 10 CFR 52 require that Detroit Edison obtain certifications from the state and local agencies with emergency planning responsibilities that the agency will participate in emergency planning and support emergency response to the proposed new plant, if constructed. At this time, we are seeking certification from the Michigan State Police that:

- The proposed emergency plans are practicable;
- The Michigan State Police are committed to participating in any further development of the plans, including any required field demonstrations; and
- The Michigan State Police are committed to executing their responsibilities under the plans in the event of an emergency.

The specific nature of the arrangements to support the emergency plan for the proposed Fermi 3 plant will be clearly established in an agreement that will be included in the Fermi 3 COLA Emergency Plan if and when Detroit Edison proceeds with construction and operation of the new plant. Your signature below also indicates that you concur with the emergency classification system (including the initiating conditions and emergency action levels) and evacuation time estimates proposed in the Fermi 3 Nuclear Plant COLA Emergency Plan.
