The staff of the U.S. Nuclear Regulatory Commission (NRC) met with the fuel cycle industry and Nuclear Energy Institute representatives in a Category 2 public meeting on January 14, 2014. The purpose of this meeting was to discuss the drivers, status, flexibility, and path forward for regulatory activities impacting fuel cycle facilities.
