3.1.2/3 rd paragraph/1 st sentence	Suggest inserting the parenthetical: <i>(where the activity is understood to be a general process such as design)</i> after ". . . life of the activity"	Clarity concern.
3.1.3/2 nd paragraph/ 2 nd sentence	Delete the word, "plant".	Clarity concern.
3.1.3/3 rd paragraph/2 nd sentence	Suggest inserting: <i>,"as necessary"</i> after ". . . and issuing procedures"	Clarity concern.
3.1.5/1 st paragraph/1 st sentence	Replace "QAM" with "QA program".	Factual error.
3.1.11/2 nd paragraph/1 st sentence	Suggest inserting, <i>"for computer program testing"</i> after ". . . test controls"	Clarity concern.
3.1.11/2 nd paragraph/3 rd sentence	Suggest replacing this sentence in its entirety with: <i>"In establishing provisions for testing, the Holtec QATR commits to implementing the quality standards described in NQA-1-2008, Requirement 11. There were no clarifications or exceptions."</i>	Clarity concern.
3.1.15/1 st paragraph/6 th sentence	Suggest placing a period after ". . . adequacy", and then begin a new sentence.	Factual error (typographical error).
3.1.15/1 st paragraph/7 th sentence	Suggest replacing ". . . , and reports provided to designated management." With <i>" . . . related to nonconforming conditions and performed periodically and reported to management."</i>	Clarity concern.
