We have reviewed the final revision to Part T, *Transportation of Radioactive Material*, of the Suggested State Regulations (SSR), received by our office on August 18, 2014, for federal concurrence. These regulations were reviewed by comparison to the equivalent Nuclear Regulatory Commission (NRC) rules in 10 CFR Part 71. We discussed our review of the regulations with Bruce Hischler on September 9, 2014.

As a result of our review, we have no comments and concur on Part T. Please note that we have limited our review to regulations required for compatibility and/or health and safety. We have determined that if the regulations as adopted, meet the compatibility and health and safety categories established in the Office of Federal and State Materials and Environmental Management Programs (FSME) Procedure SA-200, "Compatibility Categories and Health and Safety Identification for NRC Regulations and Other Program Elements."
