SUBJECT: ISSUANCE OF COMBINED LICENSES FOR SOUTH TEXAS PROJECT, UNITS
3 AND 4

Dear Mr. McBurnett:

The U.S. Nuclear Regulatory Commission (NRC) has issued Combined Licenses (COLs) NPF-097 and NPF-098 to Nuclear Innovation North America LLC and its co-applicants STP Nuclear Operating Company, NINA Texas 3 LLC, NINA Texas 4 LLC, and the City of San Antonio, Texas, acting by and through the City Public Service Board (CPS Energy), pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Section 52.97, "Issuance of combined licenses." These licenses were issued after receiving the report of the Advisory Committee on Reactor Safeguards dated February 19, 2015, and as authorized by the Commission's hearing decision dated February 9, 2016 (Agencywide Documents Access and Management System (ADAMS) Accession Number ML16040A174).

Enclosed are copies of NPF-097 and NPF-098 (Enclosures 1 and 2, ADAMS Accessions Number ML16033A020 and ML16033A047, respectively) including the Technical Specifications (Appendix A), the Environmental Protection Plan (Appendix B), and the Inspections, Tests, Analyses, and Acceptance Criteria (Appendix C) for South Texas Project, Units 3 and 4. Please note that Attachment 1 to Appendix C for NPF-097 and NPF-098 contains security-related information and as such is withheld from public disclosure. A related notice will be sent to the Office of the Federal Register for publication.

Also enclosed, are two copies of Amendment No. 8 to Indemnity Agreement No. B-108, which cover the activities authorized under Licenses NPF-097 and NPF-098 (Enclosure 3, ADAMS Accession Number ML16032A433). Please countersign both copies and return one signed copy to this office
