## Licensing Support Network Library Concerns Raised at the Licensing Support Network Advisory Review Panel Meeting

This attachment describes the concerns raised at the Licensing Support Network Advisory Review Panel meeting with Licensing Support Network (LSN) Library functionality that have now been resolved by the Atomic Safety and Licensing Board Panel (ASLBP)/Office of the Secretary(SECY)-led working group. The discussion/resolution column references the meeting transcript\* relative to those concerns addressed by the ASLBP/SECY-led working group during the meeting as well as provides a brief description for issues addressed outside the meeting.

1.	Document file view displays in text only and may not be "reliable enough" to use for document search confirmation, especially if pages have images.	The reliability of the text-only mode relates to the accuracy of the optical character recognition process used to create the document file.

2.	Searches producing significant numbers of error messages (such as when seeking to display a hundred or more documents at a time).	The LSN Library was implemented using the default setting of 3000 for the maximum number of results that would be returned. The buffer size was increased to 1,000,000 items.

6.	The "time series chart" at the bottom of the search page, which displays chronologically the same information as the facet tree results, takes up too much screen space.	It was explained that the time series chart is collapsible. 2/27/18 Tr. at 143, 147

Some document dates and related records that were provided by the originators impacts the documents' searchability and accessibility.  2/27/18 Tr. at 136–37	With respect to document dates, by default the "Time Zone Sensitivity" feature was enabled in the system, which adjusts search parameters based on a user's location. This feature has since been disabled and the system's search dates now are based on the eastern time zone.

12.	Need to retype quotation marks in search boxes. 2/27/18 Tr. at 130	The need to retype quotation marks could be based on whether the copied quotation marks are from the keyboard (") and so can be copied, or are symbols (") that, when copied, are not treated as quotation marks.
13.	The facet tree "slider" is sometimes inoperative and therefore limits the viewer's ability to see more than a certain number of facets.  2/27/18 Tr. at 135	Feature is not intended to be used for large result sets. Feature instead is intended to be used for final refinement of searches after using Advanced Search feature.
