This letter documents the Nuclear Regulatory Commission (NRC) staff's plan to perform a vendor inspection of the implementation of AZZ Nuclear/NLI quality assurance program in accordance with Title 10 of the *Code of Federal Regulations* (10 CFR) Part 50, Appendix B and 10 CFR Part 21 as they pertain to AZZ Nuclear/NLI's design, qualification, and commercial grade dedication activities related to basic components supplied to U.S. NRC regulated facilities. The NRC inspection team plans to arrive at the AZZ Nuclear/NLI facility, in Fort Worth, Texas on Monday, May 20, 2019, and will conduct an inspection through Friday, May 24, 2019.
