Dear Mr. Mays:

By e-mail dated September 30, 2020 (U.S. Nuclear Regulatory Commission's (NRC's) Agencywide Documents Access and Management System (ADAMS) Package Accession No. ML20275A094), Powertech (USA) Inc. (Powertech) submitted a request to the NRC to amend Materials License SUA-1600. Specifically, Powertech requested that the NRC staff change the address in Section 2 of Materials License SUA-1600. By e-mail dated October 5, 2020 (ADAMS Accession No. ML20279A165), the NRC staff provided Powertech with a draft amended license for review.

License Amendment No. 3, enclosed with this letter, includes a revised Section 2 to incorporate the change in the licensee's address. By e-mail dated October 6, 2020, Powertech agreed to this change to Materials License SUA-1600 (ADAMS Accession No. ML20280A630).

Because this license amendment is being issued solely to change the licensee's business address, this licensing action meets the categorical exclusion provision in Title 10 *Code of the Federal Regulations* (10 CFR) 51.22(c)(10)(iii). Therefore, no environmental review under the National Environmental Policy Act was performed for this action.

Section 7 of the Endangered Species Act (Act) [16 U.S.C. 1531 et seq.] outlines the procedures for Federal interagency cooperation to conserve Federally listed species and designated critical habitats. Section 7(a)(2) states that each Federal agency shall, in consultation with the Secretary, insure that any action they authorize, fund, or carry out is not likely to jeopardize the continued existence of a listed species or result in the destruction or adverse modification of designated critical habitat. The NRC staff has determined that a Section 7 consultation is not required because the proposed action is administrative/procedural in nature and will not affect listed species or critical habitat. The NRC staff has also determined that the proposed action is not a type of activity that has potential to cause effects on historic properties because they are administrative/procedural actions. Therefore, no additional consultation is required under Section 106 of the National Historic Preservation Act.

As a result of this amendment, the NRC staff has completed its work on Enterprise Project Identifier (EPID) L-2020-LLA-0222 (Powertech - Address change request for Dewey-Burdock Project). Therefore, this EPID will be closed with no further charges against it.
