WORK AUTHORIZATION

The U.S. Nuclear Regulatory Commission (NRC) held an observation public meeting on November 1, 2023, with SMR, LLC (SMR), a Holtec International Company (Holtec), to discuss questions regarding the limited work authorization (LWA) process for a construction permit application submitted under 10 CFR Part 50.1, 2 SMR (Holtec) requested the meeting to discuss and receive NRC staff feedback on its questions related to this topic.^{3, 4} This meeting summary satisfies the SMR (Holtec) request for review and feedback on its preapplication meeting materials.

This virtual observation preapplication meeting had attendees from SMR, LLC, Holtec, NRC staff, and members of the public.
