I am pleased to submit on behalf of X Energy, LLC (X-energy), the enclosed Controlled Unclassified Information (CUI) and Proprietary version of X-Energy's Next-Generation Integrated Transportable High-Temperature (XENITH) microreactor pre-application Regulatory Engagement Plan (REP). This revised submittal covers a brief technology overview and planned pre-application interactions with the NRC in support of future X-energy XENITH microreactor license application(s).

The enclosed REP includes information regarding the current status of the XENITH microreactor's design, and the regulatory strategy envisioned for its deployment. The REP includes our proposed licensing submittals for fiscal year 2025 as well as other key topic areas that we would like to address through pre-application interactions. Through these interactions, X-energy aims to continue its preapplication engagements with the U.S. Nuclear Regulatory Commission (NRC) staff with the primary goal of enhancing communications and reducing regulatory uncertainty by establishing a common understanding of XENITH's licensing deliverables and needed timelines.
