This is in response to your March 31, 2025, letter requesting U.S. Nuclear Regulatory Commission (NRC) authorization for Christopher J. Fong and Antonios M. Zoulis to serve as NRC Safeguards Reviewing Officials for Blue Energy Global, Inc.

The NRC staff has completed its review of your authorization request and determined that Mr. Fong and Mr. Zoulis meet the criteria specified in NRC Order EA-07-231, "Order Imposing Safeguards Information Protection Requirements and Fingerprinting and Criminal History Records Check Requirements for Access to Safeguards Information," dated September 12, 2007 (Agencywide Documents Access and Management System (ADAMS) Package Accession No. ML072220343).
